**Pay:** The City pays election judges \$12/hour (head judges \$14/hour) for attending training sessions and performing Election Day duties. A wage bonus of \$1 or \$2/ hour is added for state general elections. Direct deposit of wages is required.

**Employer Certificate:** An individual who is selected as an election judge may be absent from their place of work for the purpose of serving as an election judge and election judge training without penalty if they notify their Employer in writing at least 20 days prior to each election. (M.S.204B.195).....Employer Certificate requested

**TRAINING:**

Election judges will be required to complete a 2 hour on-line training program in preparation for the fall election. New judges will also need to complete poll book training. Head judges will have an additional training session. Appropriate election judge salary is paid for training time.
